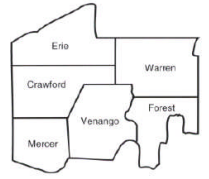

RE: 2011 DISTRICT 10 SOCCER TOURNAMENT

Attached is information regarding the **2011** District 10 Girls' and Boys' Soccer Tournament. The tournament will consist of the following number of teams:

<u>GIRLS:</u>	AAA 2 Teams	<u>BOYS:</u>	AAA 2 Teams
	AA 8 Teams		AA 6 Teams
	A 2 Teams		A 4 Teams

The District 10 Tournament will commence on Monday, October 31, 2011 and conclude on Saturday, November 5, 2011. Therefore, regions should conclude their regional schedules, to determine representatives for tournament play, by October 26, 2011. Brackets and dates were established at the August meeting of the District 10 Committee; however, times and site selections will be delayed until the October meeting.

The soccer tournament will be a regional representative tournament. The following general policy relating to qualifying for District 10 playoffs in team sports will apply to this year's soccer tournament:

1. Region champions will automatically qualify.
2. In mixed classification regions, the highest-ranking team in classification will qualify (if one is not region champion) provided there are two or more teams of the same classification.
3. A single classified team in a region with teams of higher classification can qualify automatically only if that team wins the region championship, but otherwise can qualify as an at-large team under the criteria established pertinent to each sport.
4. A single classified team in a region with teams of lower classification can qualify automatically on if that team wins the region championship, or can be considered as an at-large team provided it has a .500 record, or as an at-large team under other criteria established pertinent to each sport.
5. All other teams entering the District Tournaments shall qualify on an at-large basis, and the following criteria will be utilized in the assessment process.

The listed criteria are not in order of importance, nor are they intended to be mutually exclusive, or equal in weight, with any given situation.

- i. Overall record in respective region
 - ii. Position in respective league standing
 - iii. Number of teams of the same classification in region in relation to the number of similar classified teams in other regions
 - iv. Number of teams in the region of a higher or lower classification that may negatively impact or unduly enhance league record
6. In an situation where **two or more teams** from the same region are tied in region play and are being considered for playoff positions fewer than the number of tied teams, the following criteria will be utilized:
- i. Head-to-head among tied teams. If a tie still persists:
 - ii. Record against similar classified teams in that region. If a tie still persists:
 - iii. Overall record
7. If **more than two teams** are tied and **one team has qualified** through the above criteria, and another position in the playoffs is available, the following criteria will be utilized:
- i. Head-to-head among tied teams. If a tie still persists:
 - ii. Record against similar classified teams in that region. If a tie still persists:
 - iii. Overall record
8. If no determination is made after consideration of the above criteria, then the following criteria may be utilized in the assessment process. The listed criteria are not in order of importance, nor are they intended to be mutually exclusive, or equal in weight, with any given situation.
- i. Head to head play between teams under consideration if they have played each other
 - ii. Won-loss record, against common opponents
 - iii. League and/or regional balance
 - iv. Overall season record
 - v. Non-region won-loss record, against teams of similar classification

Note: In no case will a team of who finishes below another team of the same classification in the same region be chosen above that team.

The following are reminders and responsibilities of the school's who are anticipating entrance into this year's soccer tournament(s):

- The **top team** in the bracketing will be the **home** team and will wear **white** uniforms.
- Each school must provide **two** ball girls/ boys for each game they play.
- Each school must send **PIAA eligibility sheet(s)** to Mr. Krahe by **October 3, 2011**.
- Each school must **E-Mail team rosters (in the provided template format)** to Mr. Krahe by **October 3, 2011**, to help facilitate the production of a tournament program.
- An admission of **\$5.00** [all tickets] will be charged for all games during the tournament. Tickets are valid for **all** games played that day. Principals and Athletic Directors are to **notify** their respective student bodies and fans.
- A **three-whistle** system of officials will be used for all contests. All schools are requested to return the attached **officials' form** to Mr. Picardo by **October 3, 2011**. In addition, contact will be made with all PIAA District 10 soccer chapter presidents requesting that each chapter recommend officials to officiate the tournament based on **ability** and **availability**. The responses received from the coaches and chapters will be crosschecked for compatibility.
- District 10 **Marketing Items** will be available at all contests, as long as supplies last.
- Site facilities have restrooms available for contestants and spectators and a concession stand will be open at all times
- **Locker room** and **shower facilities** will be provided with **advanced** requests of the host facility.

Should a conflict develop concerning the scheduling of your game, please notify the Tournament Directors **immediately**. It will be resolved **if possible**; however, if a solution is not possible, all scheduled dates and times **will be followed**.

All schools qualifying for the tournament must notify the Tournament Directors at the earliest possible date, but no later than **October 3, 2011** of their interest in participating in this year's tournament(s).

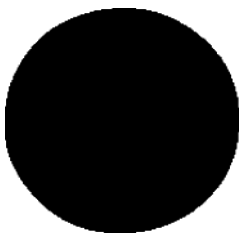

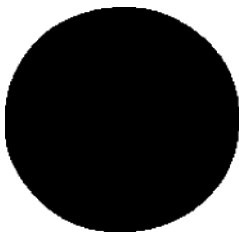


**POLICY STATEMENT FOR MEMBER SCHOOLS WITH

PIAA DISTRICT TEN MEMBER SCHOOLS ARE NOT REQUIRED TO ENTER A TEAM INTO PIAA DISTRICT TEN CHAMPIONSHIP EVENTS.

ENTRY AND PARTICIPATION BY MEMBER SCHOOLS IN THE TOURNAMENTS SPONSORED BY THE PIAA DISTRICT TEN ARE TOTALLY VOLUNTARY. ENTRY OF A TEAM OR INDIVIDUAL COMPETITOR BY A MEMBER SCHOOL INTO A PIAA DISTRICT TEN TOURNAMENT SIGNIFIES THAT THE MEMBER SCHOOL ACCEPTS THE CONDITIONS AND PROVISIONS THAT ARE INHERENT WITH THE TOURNAMENT RULES, REGULATIONS AND GUIDELINES.

FURTHER, A MEMBER SCHOOL ACCEPTS THE FACT THAT THE PIAA DISTRICT TEN CHAIRMAN, EXECUTIVE COMMITTEE, TOURNAMENT DIRECTOR AND DISTRICT TEN COMMITTEE RESERVES THE RIGHT TO MAKE CHANGES IN THE MANAGEMENT, SCHEDULE, SITES, DATES, TIMES AND OPERATIONS OF CHAMPIONSHIPS WHEN IN THEIR JUDGMENT IT BECOMES NECESSARY TO DO SO.

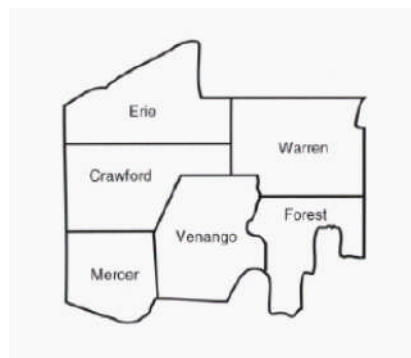
